The purpose of the report is to request the Management Committee to approve the processes to amend the Security Services contract awarded to Ithunzi Security Services, Amazim-zim Security and Mzansi Security & Training as a three (3) year contract, which commenced from 01 June 2021 – 31 May 2024.

3. LEGISLATIVE PROVISIONS

Municipal Finance Management Act (MFMA) No. 56 of 2003

4. BACKGROUND / RATIONALE

4.1 In terms of Section 116 (3) (a) of the Municipal Finance Management Act (MFMA) No. 56 of 2003, a contract or agreement procured through the Supply Chain Management Policy of the Municipality may be amended by the parties,

The Municipality on 18 September 2020, advertised on both its website and public platforms calling for bids from competent Security Service Providers for Provision of standard security guard services at various UGU District Municipal offices and plants for a period of thirty six (36) months.

Following which, through the Supply Chain Management (SCM) processes, same appointed three (3) service providers for the various zones (Zone 1, Zone 2 and Zone 3) under the municipal jurisdiction on a fixed contract with fixed contract values for each service provider per zone. The three appointed service providers were Ithunzi Security Services, Amazim-zim Security and Mzansi Security & Training. The Municipality appointed these three (3) services providers on an accepted **standard proposed rate** of R14 206.41 per security guard with annual escalations which are informed by PSIRA regulations.

During the contracted period to date, the UGU District Municipality has been faced with severe cases of vandalism, theft, sabotage of water infrastructure etc... across the various Municipal sites. The Municipality has been subjected to cable theft, vandalism of water infrastructure, sabotage of water systems which all necessitated the provision of additional security guarding services.

In addition to the above, the municipality has been faced with cases related to threats pointed towards its service delivery vehicles during service delivery protests, which necessitated that provision of additional security guarding and armed patrols be put in place in order to protect both the municipal employees and municipal assets.

Furthermore, it should be noted that there has been a number of cases where the Water Services Department (Core Function), has been subjected to working
