c 289/05/22 Special Adjustments Budget for the 2021/22 Financial Year

Her, Worship the Mayor took members through the item.

She reported that a joint meeting of the Executive Committee and the Portfolio Committee on Finance was held on Thursday, 12 May 2022; whereby the said item was discussed.

She informed Council that the objective was to notify and seek approval of the Special Adjustments Budget for the 2021/2022 financial year.

She then informed Council that on 10 March 2022, a letter was written to the Head of Department of KZN CoGTA requesting for funding of R6 400 000.00 to implement the refurbishment / replacement of the existing mechanical, electrical equipment, and civil works of the Umtamvuna System for the purpose of enhancing equipment reliability and improving the water security under the southern area of supply in the Ray Nkonyeni Municipality.

She pointed out that the project intended to immediately address water interruptions due to equipment breakdowns which were affecting the Ray Nkonyeni Local Municipality rural and urban communities and businesses.

She then took members through the project implementation as reflected on page 2 of the agenda.

She reported that the funding was approved, and that the transfer of the funds was actioned by CoGTA on 18 March 2022 and that the said funds were received by the Municipality on 24 March 2022.

She emphasised that in line with the legislation, a special budget adjustment had to be approved by Council no later than 17 May 2022.

She then highlighted the recommendations.

Thereafter, Cllr Henderson moved for the acceptance of the recommendations and was seconded by Cllr Manyoni.

c 290/05/22 SANDF Camp Base at Ugu Sports and Leisure and Related Matters: Waivering of Tariff of Charges for the Ugu Sports and Leisure Centre

Her, Worship the Mayor took members through the item.

She pointed out that a request was received for SANDF to use the Ugu Sports and Leisure Centre as a camp base; hence the request for the charges to be waivered.

Giving members a background to the item, she reported that at a Joint Operations Committee (JOC) meeting held on Monday, 02 May 2022, it was indicated that the SANDF leadership had identified the Ugu Sports and Leisure Centre to be an area for them to set up a camp for the period of their response to the recent disaster, including support to the Ugu District.

She further reported that it had been indicated that the SANDF had requested to utilize the Sportsfield C, electricity (lighting) and ablution facilities at the Ugu Sports and Leisure Centre for a month for 300 people.

She informed Council that it was recommended that the SANDF pays the Municipality for the use of the Ugu Sports and Leisure Centre for the accommodation as well as the use of water.

Commenting, Cllr Ndovela sought clarity on what assistance was the SANDF going to provide to the Ugu District.

Cllr Machi emphasised that she did not have a problem with the SANDF using the Ugu Sports and Leisure Centre, as long as the SANDF was going to pay the Municipality.

In response, the Mayor explained to Council that given that the Ugu District was declared a disaster, the SANDF was sent out to the affected areas to assist; hence the SANDF would be assisting all the Sector Departments as well as the Municipalities that were badly affected by the recent disaster. She cited an example of the Ray Nkonyeni Municipality, whereby the SANDF would assist the said Municipality with the cleaning of roads, bridges, streams and so forth.

She further explained to Council that when there were Programmes, the SANDF would be led by the Mayors of the respective Municipality.

Thereafter, Cllr Schmidt moved for the acceptance of the recommendations and was seconded by Cllr Machi.
