# C 10/01/16 Presentation by the Auditor-General of South Africa

Mr Perumaul tabled the Audit Report for the financial year 2014/15 to Council.

He mentioned that the Auditor-General of South Africa had a constitutional mandate and, as the Supreme Audit Institution (SAI) of South Africa, it existed to strengthen the country's democracy by enabling oversight, accountability and governance in the public sector through auditing, thereby building public confidence.

He stated that even though the audit outcome showed a bit of improvement when compared to last year's report, he said that there was still a lot of work that needed to be done in order to obtain a Clean Audit for the 2015/2016 financial year.

He pointed out that both the Leadership and Management did not exercise oversight effectively over policies and procedures regarding the annual financial statement, procurement and contract management, expenditure management and asset management.

He then highlighted the following:

- Focus of their Audits;
- Various Categories of the Audit Outcomes;
- Audit Outcome 2014/2015;
  - Previous Year Audit Opinions;

With regard to the Current Year Audit Opinion, he reported that Ugu District Municipality received a financially Unqualified Audit Opinion with Emphasis of Matter:

- Restatement of Corresponding Figures;
- Material Losses and Impairment;

# He highlighted the following:

- Findings on reporting on predetermined objectives;
- Additional Matters: Achievement of Planned Targets;
- Material Adjustments to the Annual Performance Report;
- Compliance with Laws and Regulations:
  - Annual Financial Statements:
  - Asset Management;
  - Procurement and Contract Management;
  - Expenditure Management
- Internal Controls:
  - Leadership;
  - Financial and Performance Management;

Taking members through the Audit Opinion for the Ugu South Coast Tourism; he advised members of the Previous Year Report and Audit Outcomes and reported on the Current Year Audit Opinions which was Unqualified with no material findings, which meant a Clean Audit Opinion.

He then took members through the Audit Opinion for the Ugu South Coast Development Agency; he advised members on the Current Year Audit Opinions which was Unqualified with findings on compliance with laws and regulations.

He also took members through the Dash Board Report for:

- Leadership;
- Financial and Performance Management; and
- Governance

In addition, he took members through the following:

The Municipal Manager explained to Council that the rationale was to inform members of Circular 01/2016 regarding the Local Government Elections Registration Weekends.

He pointed out that Circular 01/2016 was received from SALGA on Wednesday, 27 January 2016 and that the objective of the said Circular was to make Municipalities aware that, in terms of legislation, the Local Government Elections could take place between 18 May 2016 and 16 August 2016.

He emphasised that however, the exact date of the 2016 Local Government Elections would be proclaimed in due course.

He advised members that Municipalities were requested to encourage voters to firstly check their voter registration status and; to ensure that voters take advantage of the voter registration weekends.

He indicated that the Independent Electoral Commission (IEC) had confirmed:

- The 5<sup>th</sup> and 6<sup>th</sup> of March 2016 and the 9<sup>th</sup> and 10<sup>th</sup> of April 2016 as the targeted voter registration weekends for the 2016 Local Government Elections.
- Voters were now able to check their voter registration status by sending an SMS containing their ID Number to 32810.

He said that Municipalities were accordingly requested to disseminate this information to communities in their respective municipal area.

He pointed out that Municipalities were encouraged to publicize this information within their various mediums of communication including but not limited to: Municipal Websites, Pamphlets, Loud Hailer, Billing Notices, Municipal Newsletters, Public Meetings, Local Radio Stations and Social Media.
