Following up on the court judgement on the matter relating AfriBus. vs Minster of Finance on the validity of the Preferential Procurement Policy Framework Regulations 2017. The National Treasury issued an Instruction Note that:

- Tenders advertised on or after the 16th of February 2022 must temporarily be put on hold until the Constitutional Court temporally suspend the judgement or decides otherwise.

Due to this unforeseen outcome/judgement of the Constitutional Court normal competitive bidding processes were on hold. The clarity was provided by the courts and adverts resumed June 2022. The extension for the provision of the service is necessary whilst the new tender process is underway.
