1. INTRODUCTION

1.1 Background

The town of Margate is serviced by both water-borne sanitation as well as by septic tanks and conservancy tanks.

The conservancy tanks are de-slugded monthly by vacuum tanker and the residents are billed for this service. In some instances, residents will require the second monthly draw in a month. The conservancy tanks frequently overflows and this has contributed to the pollution challenges in Margate with accompanying odours.

Most of the wastewater flows from Margate gravitate to Pump Station 3A which conveys the flow to Pump Station 4A, which ties into the Margate WWTW via the rising main. The balance of the wastewater flows directly into the Margate WWTW.

Wastewater flows from Catchment-1, will gravitate to Pump Station 3A via the existing network within this area while flows from Catchment-2, 3 & 4 will gravitate to pumpstation 4A.

The existing bulk sewer reticulation which will convey the new wastewater flows is deemed sufficient to cater for the additional flows from the project areas.

The project is situated in Margate, Ray Nkonyeni LM, Ward 6 within the Ugu District which is located on the South Coast of KwaZulu Natal.

3. Scope of Work


The planned scope of works is to provide sewer reticulation infrastructure to approximately 489 plots in Ward 6, within the Ugu District Municipality, that are currently without the waterborne sanitation. The reticulation system will discharge into the Margate WWTW. There is also Mechanical and Electrical components to be upgraded on the Margate 3A sewer pump station.

- 3.1 The scope of works consists of the following components:
 - Construction of 14.5kmx160mm diameter uPVC reticulation network.
 - Construction of 2,6km x 200mm diameter uPVC reticulation.
 - Construction of 489 No. x 110mm diameter uPVC internal house connections.
 - · Manholes and all associated works.
 - · Mechanical and Electrical components.

4. Project Objectives

- > To provide an adequate, reliable and safe sanitation system for the project area.
- > To create temporally employment during the construction of the works.
- > To ensure financial and institutional sustainability of the sanitation service.
- > To ensure cost recovery for the sanitation service delivery.
- > Community participation and governance in the provision of the sanitation service.
- > To ensure sanitation health and hygiene promotion.
