Bids are hereby invited from accredited service providers for Provision of Cash-in-Transit Security Services to Ugu District Municipality for a period of thirty-six (36) Months.

Bid documents are obtainable from the Ugu District Municipality office in Port Shepstone at No. 28 Connor Street as from **Tuesday, 02 September 2025**, at a non-refundable payment of R1000.00 (No cheques will be accepted). The bid will also be advertised on the municipality's website and documents can be downloaded from the website and the e-tender portal, free of charge.

Bids completed in accordance with the conditions indicated in documents, must be sealed and endorsed with the relevant contract number and be deposited in the official tender box at the foyer of Ugu District Municipality on 96 Marine Drive, Phase 2 Building, Oslo Beach not later than **12h00 on Friday, 03 September 2025**, at which time bids will be opened in public. Bids that are submitted late, incomplete, unsigned or by facsimile, electronically, couriered or not completed in black ink will be rejected and not accepted for further evaluation. Bids submitted must be valid for a period of **90 days**

A compulsory briefing session will be held at **Ugu District Municipality on 96 Marine Drive, Phase 2 Building, Boardroom 1**, on **Thursday, 04 September 2025 at 12: 00**. Bidders who fail to attend this compulsory meeting will not be considered for further evaluation.

The bid will be evaluated on Functionality, Price and Preference. Bidders that score less than 60% for functionality, will not be evaluated further.

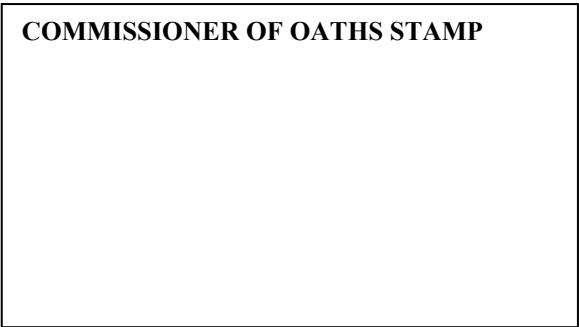
