Bid documents are obtainable from the Ugu District Municipality office in Port Shepstone at No. 28 Connor Street as from **Tuesday, 02 September 2025**, at a non-refundable payment of R1000 (No cheques will be accepted). The bid will also be advertised on the municipality's website and documents can be downloaded from the website and e-tender portal, free of charge.

Bids completed in accordance with the conditions indicated in documents must be sealed and endorsed with the relevant contract number and be deposited in the official tender box at the foyer of Ugu District Municipality on Marine Drive, Oslo Beach, Port Shepstone not later than **12h00 on Friday, 03 October 2025** at which time bids will be opened in public. Bids that are submitted late, incomplete, unsigned or by facsimile, electronically or not completed in black ink will be rejected and not accepted for further evaluation. Bids submitted are to hold good for a period of **90 days**.
