## **ENHANCEMENT OF EMERGENCY RESCUE VEHICLE**

### **VEHICLE REPAIRS:**

- The vehicle must be stripped, and all damaged areas be repaired.
- The complete vehicle must be prepped for painting.
- A good quality edge primer must be used on the vehicle.
- The vehicle must be painted with a 2K based paint of high quality.
- The windscreen must be removed and the area around it be painted before a new one is fitted.
- The broken windscreen must be replaced with a SABS approved unit.
- The vehicle must be fitted with a bull bar that attaches to the chassis for extra strength and wrap around the headlights. It must not be the nudge bar type.
- Repairs to both car seats, with similar fabric.
- Procurement and Installation of dashboard camera (complete set)
- Procurement and Installation of FM Radio.
- Procurement and Installation of new 40-inch TV screen for drone usage (to be connected to the existing invector).
- All work done must have a 1-year warranty against faulty workmanship or material.
- Vehicle must be branded with Disaster Management and Fire Services Logo.

1.4 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.5 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“The Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
