CHLORINE SAFE HANDLING SPECIFICATIONS

Vendor must produce certificates for training rendered (NQF3 or higher). Training provided must be a theory and practical (max. two days) session demonstrating on the following key requirements.

- Service provider must be an accredited training service provider on chlorine handling
- Compliance requirements of the Occupational Health and Safety Act
- Explain best practices for safe handling and usage of chlorine gas
- Interpretation of MSDS (material safety data sheet) and application in the handling of chlorine
- Explain personal protective clothing and equipment and its use in chlorine environment
- Interpretation of different chlorine containers and their components
- explain detection methods for finding chlorine leaks
- Loading, handling, transportation and storage of chlorine cylinders
- Connecting and disconnecting chlorine drums
- Instrumentation settings for dosage
- Dosing configuration
- Chlorine safety equipment (shut-off valves, chlorine sensors, alarm, strobe light etc.)
- Service provider must provide his/ her audio-visual equipment and manuals
- Scrubber system and how it works
- Signage

- Evacuation procedures

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
